Reps from The Citizen's Committee on Youth, Connie Sayles(Case Manager) and Chaz Atkinson attended the meeting. Work with youth 14-21 but concentrate on 14-16. Provide employment and training for youth. Placed in companies in the City with hope that the employers will hire on a more permanent basis.

Applications including a physical can be obtained starting 2/1 for summer jobs. KHCC can hire from CYSB. A potential work site would have to get a work site doc submitted.

Beverage Cave Hearing: So far there are 40 persons committed to attending the hearing on 1/30. Work is in progress to set up for residents to testify and for transportation to the hearing.

Josh will be attending the FOP Meeting on 1/14. He reported that there would be additional locations to dispose of toxic chemicals in the City. COPs is still patrolling the area.

Jamie Donaldson, resigned as Chair of the Youth Committee. In light of this, it was decided that we would not pursue presenting a job fair for the youth in 2004. Instead, efforts will be made to direct the youth of KH to other available programs. Mimi will check with Jamie to see if she has information or suggestions.

Todd and Stefanie Stommel resigned as Chair(s) of the Beautification Committee.

Replacements for both committee chairs are being sought.

Bruce Long was welcomed to the meeting. Bruce is the new committee chair for Housing.

It was pointed out that sightings for housing code violations have caused hardships for some residents in the area. A resident requested a letter from KH detailing contributions to KH by residents. The Board agreed that it is the intent to get rid of blight in KH and not to cause hardship for persons in the community that have challenges. The final decision on this matter is not available.
