Fire Report: 37% of deaths due from fires are because of no batteries being in the smoke detectors.

*There are two types of detectors: ionization and photoelectric. There are also smoke detectors for the deaf which have blinking lights (also vibration).

*Place one outside every room... Test monthly... Clean them yearly (remove dust)... Replace batteries yearly, although newer detectors may have an enclosed battery that is good for 10 years.

*Fire Drills: start at an early age. Teach your child their address, how to describe the fire location and how to call 911.

*Sign up for Smart911 at smart911.com

*When building improvements are made, notify the city building department.

Police Report (Off. Jason Rice): Crime Stats report reviewed.

*Capt. Aaron Jones discussed the shooting on Coleridge... Montgomery Rd restriping: many complaints due to slower traffic. We cannot do anything about the change. It can be taken up with the City Council. However, statistics have shown the change has decreased the number of accidents.
