### Schools of Choice 2003-04 Enrollment begin in October

The Schools of Choice umbrella covers the magnet elementary schools and all the district's high schools. All CPS high schools now are citywide schools, meaning they are open to any student living within the district if the school has space and the student meets eligibility requirements. For more information call Ken Wilson, Public Affairs, 475-7049.

### **Enrollment Dates:**

October 14-16 2002: Magnet students are automatically enrolled into the next level of a magnet program. Siblings of students already enrolled in a School of Choice may apply to the sibling's School of Choice.

Tuesday, October 22, 2002: General enrollment begins for all other students continuing until space is filled. Magnet schools may enroll inquadrant students only.

Monday, December 14, 2002: Out of quadrant enrollment begins for magnet elementary schools, if space is available.

In reference to the same property and to our community's schools, resident Duane Holm made a motion that the following three actions be taken by the KHCC Executive Committee. After discussion and review of handouts provided by Duane, Council seconded and passed the motion with a vote of 23 for, 0 (zero)against, 4 abstentions.

- 1) KHCC Executive Committee will propose to CPS that Woodford School be the KH neighborhood school,
- 2) KHCC Executive Committee will propose to CPS that Woodford School maintain its Paideia school status, and

3) KHCC Executive Committee will propose that CPS transfer or exchange ownership of the Kennedy-and-Montgomery property to the **Cincinnati Recreation Department for** use as the Kennedy Heights **Comprehensive Community Center.**

Mimi also requested Neighborhood Networker volunteers for streets not yet represented.

### TREE WORK

Urban Forestry is currently conducting a comprehensive tree lawn preventative maintenance survey in KH. This will determine which trees need to be removed or trimmed. As soon as it is completed, contracts will be signed and the work will be done.

Following that, Urban Forestry will conduct a comprehensive tree *planting* survey to determine those spots on our tree lawns where new trees will be planted. An abundance of mature trees is one of the qualities of KH that attracted many of us.

It is our job to steward this process so our grandchildren will have shade and oxygen! Property owners who wish to appeal the planting of a tree will have that opportunity.
