KHCC **Constitutional Amendments**

The Kennedy Heights Community Council is a non-profit, tax-exempt corporation. The corporation operates under the rules of its own constitution or "bylaws." When constitutional amendments are proposed, they must be presented at two monthly meetings in a row.

A set of amendments was presented at the March meeting and will be on the agenda for a membership vote on April 17.

The proposed amendments will change KHCC's election process.

For many years (if not from the very beginning), elections have been held at the June meeting, with the new board taking office in July, just in time for summer vacations.

The amendments, if adopted, will move elections from June to November, with Board terms running from January through December.

2007 would be a transition year. With no election in June, the amendments extend the terms of the present Board members through December.

All KH residents are eligible to vote on the proposed amendments. Amending the constitution requires approval of two-thirds of the residents present at the general meeting.



Foreclosures in KH

Ohio now leads the nation in foreclosures. And KH homeowners have unfortunately contributed to that scary statistic.

According to a study of court data by Working in Neighborhoods, 1,533 Cincinnati homes were sold at sheriff's auctions in 2006.

45 of those homes were in Kennedy Heights. Only 11 neighborhoods had higher numbers.

In Search of Win-Win-Win City Schools & Community

Excerpts from a 3/21 presentation by KHCC President Ernest Barbeau to the Joint Committee of City Council and Cincinnati Public Schools (CPS)

Over the next few years, CPS's Master Facilities Plan will lead CPS to dispose of surplus and unwanted properties in many neighborhoods. For some neighborhoods, CPS decisions can pose either a significant opportunity or a challenge for neighborhood revitalization. What CPS does with these properties has important implications and opportunities for three stakeholders—CPS, the City, and the neighborhoods.

Only the Park Board owns more property in KH than CPS. CPS owns about 25 acres in KH: Shroder and Woodford Schools and the site of the former Kennedy School at Kennedy & Montgomery.

By selling properties, CPS can gain needed short-term revenue, and on a long-term basis expand its revenue base thru property taxes. If the new use attracts more families to our neighborhoods, CPS could serve more students. For the City, redevelopment of these properties presents an opportunity to increase its revenue **and** population base.

Based on our discussions with potential developers, we realize that a development compatible with a neighborhood's vision can only occur if there is a healthy mix of private and public funding.

We strongly recommend that this Committee take the lead in exploring ways in which CPS and the City can develop partnering relationships between CPS and City Council and neighborhoods, such as community councils. One area that needs extensive exploration is the question of public funding that can result in a win-win situation for each of the three stakeholders.

An immediate result of Ernie's comments: a mid-April tour of KH (and the three school properties) for several members of City Council.

72 vacant houses in KH ?!!

When the topic of vacant houses came up at the March CPOP meeting, no one had a good idea as to how many there might be.

The official count from the City Building Department was under 5. But the City only lists buildings that it has ordered vacant due to unsafe or unsanitary conditions. There are more than 1,700 of those eyesores citywide.

So Ben Pipkin and others decided to count them--the old fashioned way. They walked and drove most of the KH streets. And noted houses that looked vacant. Some obvious (boarded windows), others only noted after talking with neighbors.

Not a good sign. And one that KHCC will definitely have to address.
